Quotations must appear on an official letterhead or be endorsed by the official stamp of the submitting entity. Quotations must be submitted in a sealed envelope (which is clearly marked with the reference number above) in the Municipal tender box, by no later than: 14 March 2017 at 11:00.

The following conditions, read together with the Municipality's SCM Policy will apply:

- Suppliers must be registered on the National Treasury Central Supplier Database (CSD).
